THE ELORA - CATARACT TRAILWAY - ONTARIO

The breeze among the trees

While cycling down the trailway, observing and listening to the falling leaves, I'm reminded of how beautiful fall is and how peaceful it is to be in nature.

As I ring my bell, I enjoy the glances, smiles, and cordial greetings from others on this multipurpose trail. Along its winding journey through eight municipalities, singles, couples, families, friends, and acquaintances socialize. The Trailway furnishes us with a retreat from the pressures of modern life.

A determined group converted an abandoned rail line into a recreational trail corridor 31 years ago. They bought the 47-kilometre CPR Elora to Cataract rail corridor with two conservation authorities, the province, and enthusiastic locals. It showed how different levels of government and community organizations could acquire and subsequently manage a former railway rightof-way following its conversion to a recreational trail.

Thousands of people have enjoyed our Trailway, a true gem. As the new chair of the Elora Cataract Trailway Association, I plan to protect this treasure for future generations. much like the trailblazers who came before

Upon joining the Board, what encouraged me to accept the role of Chair? As a former municipal councillor and GRCA Board member, I supported the Trailway because of its importance to the communities it serves. I bring 24 years of human resources leadership and management experience specializing in organizational development, helping turn a 75-person consulting engineering firm into a 450-person global leader. I serve on Centre Wellington Township's Healthy Communities Advisory Committee and its Environment and Active Transportation subcommittee, which is participating in developing the Township's Active Transportation and Mobility Master Plan.

With a fresh perspective and the expertise of a consultant, I have devoted the last six months to learning about this organization, analyzing its governance records, board materials, newsletters. and archive resources from the 1990s. I have cultivated collaborative ties with my CVC, GRCA, and Centre Wellington Township contacts, conducted a visual survey of the Trailway, interviewed trail users at various sections along the Trailway, and distributed and reviewed our recent online trail user survey.

With this understanding, I know the direction we need to take. The journey requires a steady hand, adaptability, collaboration, and strenuous effort. There will be trials and disappointments, some already experienced, but calm seas never make great sailors. Barriers present opportunities to learn and use new ways and approaches. Unless repeated, mistakes are learning opportunities. Nothing ventured, nothing gained. I adhere to my clan's motto, "Fortitudine," and my mantra, "Dare to Care."

Imagine if we all exercised "Dare to Care" by carrying out what we bring in, including our dog's litter, leashing our dogs when near people, slowing down on our bike when approaching people, ringing our bell to notify them of our presence, and stepping aside to let others pass—in short, respecting every trail user's right to enjoy the trail. These simple activities require little effort yet provide so much for us and others. Help me make this part of our trail culture.

I've said enough. It's time to begin our journey together and see where our new path leads us.



OUR CONSERVATION PARTNERS

CREDIT VALLEY CONSERVATION AND GRAND RIVER CONSERVATION AUTHORITY

The Credit Valley Conservation, founded in 1954 by Credit River watershed municipalities, turned 70 this year. Much like the GRCA its mandate is to address growing issues about water quality, flooding, and soil erosion from changing land uses and deforestation. Credit Valley Conservation is helping to create the 100-km Credit Valley Trail from Orangeville's headwaters to Lake Ontario in Mississauga. There are 32 kilometres of connected path and 68 to go. This link provides more information about this worthwhile project: https://creditvalleytrail.ca.

The Grand River was recognized as a Canadian heritage river 30 years ago this year. Events were held across the watershed to celebrate.

VANCOUVER ISLAND RAIL TRAIL

The recently constructed rail trail between Parksville and Coombs on Vancouver Island runs for seven kilometres along the right of way of the Esquimalt & Nanaimo Railway (E&N Railway).

The railway was originally built by Sir Robert Dunsmuir, a Scottish coal miner who came to BC indentured to the Hudson's Bay Company and became a coal baron, member of the Legislature, and the wealthiest man in BC.

The E&N was given land grants to aid its construction, which amounted to about 20% of Vancouver Island. This would account for the principal difference between the Coombs to Parksville trail and ours.

While the multi-use trail looks much like the original Elora Cataract Trailway, 3 meters wide with a stone chip surface and drainage into ditches on either side, the trail does not run on the original rail bed like ours. It runs on the wide E & N right of way next to the rail tracks that have been waiting, now for 15 years, for a

commuter train, with no date in sight.

The Coombs to Parksville trail has been described as not very scenic, except for the bald eagles overhead.

The morning trail user begins in Parksville by turning their back on the sun as it rises over the coastal mountains, casting its light on the waters of the Straits of Georgia and the Parksville beachfront.

The trail proceeds through woods and meadows before ending at Coombs, where the big attraction is the goats grazing on the roof of the local grocery store.

Unlike our trail, there are no views of rich Southern Ontario farmland. There is no need to continue the comparison. If they extend the trail to 38 K BC, it would be scenic. Indeed, the E & N right of way could accommodate a genuinely spectacular trail should a process be found to build one over its entire length.

NOT-FOR-PROFIT CORPORATIONS ACT

The ECTA Letters Patent (Articles of Incorporation) amendment to conform with the Not-For-Profit Corporations Act and the approval of the related amendments to the by-laws will be addressed at the next annual meeting.

Owing to a lack of quorum, these matters were not addressed at the special meeting in September.

The Act provides that when a corporation's articles have not been amended to conform with the Act, the

provisions of the Act will apply in the event of a conflict.

By-laws amended by the Board apply until the next membership meeting, when they must be approved or rejected.

While we would like to have met the statutory deadline for making amendments to the articles, waiting until the annual meeting should be equally satisfactory.

THE TRAIL BECOMES A STREAM

Your editor embarked on a long walk on the trail without checking the weather forecast and found himself caught in a downpour. Standing on the grass buildup on the side of the trail and looking at the trail surface, I saw that it had transformed into a stream an inch or so deep with a significant current, even though the trail at that point was, to a walker, relatively flat.

Could this explain the ruts that have appeared on parts of the trail where the grade is more pronounced?

REPORTING TRAILWAY ISSUES

The Credit Valley Conservation (CVC) and the Grand River Conservation Authority (GRCA) are dedicated to keeping the Elora Cataract Trailway safe and secure for all users.

You may help in this process by reporting any safety concerns you encounter, such as a fallen tree, a stretch of washed out trail, encroaching vegetation, etc.

Gather the following information and send it to info@trailway.org. Your observation will be added to our registry of reported concerns and forwarded to the appropriate conservation authority. ECTA has initiated a registry of reported concerns to monitor all concerns, focussing on recurring problems.


- 1. What? Describe the issue.
- Location? (for example, between KM marker x and y, between gates x and y (every GRCA gate is numbered) or approximate distance and direction from nearest road. See GRCA map showing gate locations.

TRAILWAY RE-WIDENING

The ECTA, through the GRCA, widened and restored approximately 5.3 kilometres of trail surface lost to encroaching vegetation. On October 30, 2024, the work began with a tractor pulling a TrailPro, followed by a compactor. The GRCA's contractor restored trail sections between Gates 9-12, 14-15, and 20-21.

The sites were chosen based on trail user survey responses from this


summer and observations from ECTA Board members and GRCA employees. We are grateful to the Township of Centre Wellington, Nexans Canada Inc. of Fergus, the GRCA, and private donors for providing financing to complete this year's project.

BLYTH TUNNEL COMPLETED!

Here in Southwestern Ontario, we are fortunate to have relatively easy access to several trailways for recreation and safe travel between communities.

Indeed, frequent users of our E.C.T. also enjoy our neighbouring G2G Trail, stretching 132 km between Guelph and Goderich. The eastern portion of this route offers straightforward access for cyclists and walkers from Centre Wellington, whether joining just west of Guelph or at West Montrose.

The G2G is similar in many ways to our E.C.T. Both were former C.P.R. lines and, as a result, link urban and more rural areas. Both trailways are vehicle-free except for periodic road crossings.

In this regard, we'd like to extend our congratulations to all the folks at the G2G following the successful completion of the Blyth Tunnel Restoration Project. This project enables users west of Blyth (east of Goderich) to avoid a challenging and busy road crossing. As with all such projects, it took time, the efforts of many, and both public and private financing, large and small, to bring it to fruition.

In a similar vein, E.C.T.A. is supporting and actively consulting toward the establishment of a new and improved route through Fergus. This route will enhance safety and access for frequent users and visitors to Centre Wellington, who will benefit from a more straightforward route through Fergus.

We will keep you posted.

Association volunteers and Board members conducted pop-up trail user surveys at several locations along the entire length of the Trailway during July and August. Our team interacted with 396 trail users of which 181 chose to complete the online survey. This very impressive number of responses confirms the vital nature of our trailway to its users.

DONATIONS

The Elora Cataract Trailway Association serves as the eyes and ears of our two conservation authority partners, Credit Valley Conservation and Grand River Conservation Authority. We track trail activity and usage, perform trail user surveys, and lobby for operational, maintenance, and capital upgrades from our two partners. We also interact with the municipalities through which the trailway traverses. An example is current discussions with Centre Wellington Township to establish a new route through Fergus, connecting the east and west sections of the Trailway.

We fundraise for trailway capital improvements (e.g., trail re-widening and full restoration), projects (e.g., signs, new kiosk map boards, and heritage photos), and safety incentives (e.g., bike bell giveaways to encourage cyclists to notify their passing on the trailway).

This fall, for \$10,500, we reclaimed another 5.3 km length of trailway surface from encroaching vegetation.

Given our non-charity status as a non-profit, we direct all donations to the Credit Valley Conservation Foundation (CVCF) or the Grand River Conservation Authority Foundation (GRCF), depending on the fundraising endeavour. All donations designated for the Elora Cataract Trailway (ECT) benefit the trailway's improvements and major initiatives. Both foundations will issue tax receipts.
